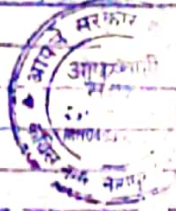

Article 3

The financial supports for the activities mentioned in Article 2, will be sought from the national and/or private organizations of both sides

Article 4

This Memorandum of Understanding shall become effective from the date of its signing by the representatives of both institutions and shall remain in effect for **five (5) years** and can be extended by the written mutual consents. Either side may terminate this agreement at any time by giving a written notice in six (6) months advance to the other institution.
