Women Grievance Redressal Cell of SSES Amt's Science College Congress Nagar, Nagpur organized a **guest lecture on 'Health And Hygiene' on 8th April 2022.** In continuation of its human endeavor and to bring about health awareness among the girl students and lady teachers, SSES Amt's Science College, Congress Nagar Nagpur has conducted an awareness program on Polycystic Ovary Syndrome (PCOS) & its Challenges on April 8, 2022, in the college conference hall under the banner of Women Grievance Redressal Cell. The lecture was delivered by renowned Obstetrician & Gynecologist Dr.(Mrs.) Charu Baheti, Director, Sure life Hospital, and Nagpur. She addressed the gathering about hygiene and polycystic syndrome symptoms.

She explained all the symptoms and syndrome of PCOS by showing a presentation. She described various causative factors, diagnostic parameters, and complications of PCOS in detail. She further explained myths and facts about PCOS and various measures that can be taken for the prevention/management of PCOS. She also gave information about the causative factors of PCOS such as stress, junk food, overweight, and lack of exercise as well as symptoms of PCOS including irregular or absence of periods, acne, extra hairs on the neck & face, baldness, weight gain etc. She suggested that diet, regular exercise, and proper medication will be helpful for the management of PCOS.

She also gave necessary information about reusable silicone cups during the menstruation period which is safe and eco-friendly. The program winded up by open discussion and participation from teachers and girls students which was answered and discussed by the resource person. The program ended successfully with a very positive note in the presence of respected Principal Dr. M. P. Dhore, Convener Dr. Yogita Meshram, and members Dr. Vrushali Kinhikar.
