This Memorandum of understanding is signed between

Shri Shivaji Education Society, Amravati's Science College Congress Nagar, Nagpur 440012, M.S. (India) Which was established in the year 1965 and affiliated in Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur and acting through the Principal, Dr. Mahendra P. Dhore

AND

**Shree Molecular and Diagnostic Lab, Nagpur.**

The purpose of this MOU is to develop academic & educational co-operation and to promote mutual understanding between the two organizations.

Both organizations agree to develop the following collaborative activities in the academic and corporate areas of mutual interest on a basis of equality and reciprocity.

- a) Exchange of students and staff.
- b) Promoting collaboration in fields of mutual interest.

### I. FIELD OF CO-OPERATION :

B) The said academic interaction and intellectual assimilation may include

- 1) Faculty / staff development and exchange
- 2) Exchange of students for on job training.
- 3) Seminars, Research, Conferences and workshops.
- 4) Collaborations in the sharing of academic data, scientific information, intellectual property, articles and publications.

### 2. EXCHANGE OF STUDENTS / TEACHERS / INDUSTRY PERSONNEL.:

a) Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects. Teachers, researchers, guides and students of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both the institutions.

### 3. MISCELLANEOUS

- a) The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b) The parties to this memorandum may be mutual consent, add modify, amend, delete review or revise any term(s) and condition(s) of this agreement.
- c) The intent and implementation of this memorandum is subject to the polices of the respective states (in case of inter-state agreements) and the laws of the land.
- d) The MOU shall remain in force for a period of 10 years from the date of its signature and seal, and may be terminated by either side by giving a 2 months' notice to that effect in writing. However, notwithstanding the notice of the intent terminate the memorandum, all rights obligations and corresponding the duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

The parties of this MOU undefaced to great as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms and confidentiality and mode of disclosure shall be as per mutually acceptable terms.

O This MOU shall be require the ratification of the competent academic executive body of both the institutions.

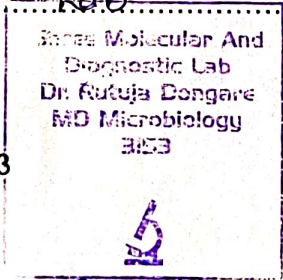
