



**INDEPENDENT AUDITOR'S REPORT
DEGREE COLLEGE ACCOUNT**

1. REPORT ON THE FINANCIAL STATEMENTS

We have audited the accompanying financial statements of **DEGREE COLLEGE ACCOUNT, SHIVAJI SCIENCE COLLEGE, CONGRESS NAGAR, NAGPUR** (managed by Shri Shivaji Education Society, Amravati), which comprises the Balance Sheet as at March 31, 2024, the Income & Expenditure Account and also the Receipt & Payment Account for the year ended on that date.






