Whereas, provision is made to participate in any other programs, services or activities designed for cultural, economic and social improvement as may be necessary and possible to achieve the objectives of the University as per the provisions of rights and duties in Section 5 (47) (h) of the Maharashtra Universities Act 2016 and;

Therefore, the aim of university education is not limited to study, teaching and research but to make a socially useful civilized citizen is one of the main objectives of education and:

In which sense, the overall development of a student's personality cannot be achieved only through book or intellectual education. In fact, the development of personality is truly developed through the balance of body, mind, intellect and soul. Students should think about all these aspects while pursuing higher education

The head of the academic department of the college, teaching and non-teaching staff as well as philanthropic persons of the society, for the Affiliated to Rashtrasant Tukdoji Maharaj Nagpur University, keeping educational work of the students from the funds generated in view the various objectives that the social responsibility fund of the company or companies should be funded.

For College Students (College Student Responsibility Fund) "College Launching Student Liability Fund Scheme" (CSR) will actually benefit the students and;

WHEREAS, if the said scheme is implemented by the college, it will be useful to the students admitted to the college to provide various employment opportunities as well as to lead the society as competent citizens and;

In the sense that in the meeting of the Management Council held on 22.02.2019 approval has been granted to prepare the draft rules of the scheme as per provision No. 56 (1) (f) of the Maharashtra Public University Act 2016. Accordingly, the sub-committee constituted has prepared the following draft rules.

● Purpose:

To provide financial assistance to needy and prospective students studying in the college for academic, sports, research and other necessary educational needs.

Fund Collection for the Scheme:

- A minimum amount of Rs.100/- (literal rupees one hundred) or maximum funds can be deposited into the college accounts from the monthly salary of the head of the department, teachers and non-teaching staff of the college. Since the said fund collection is voluntary, no one can be forced to collect the fund under any circumstances.
- The beneficiary student can deposit the amount/fund received in the scheme or less or more funds in the said scheme in the future or in the near future. Funding of the beneficiary student under the said scheme will not be mandatory under any circumstances.
- In this scheme, philanthropic individuals of the society, educational, social organizations and industrially related companies can deposit social responsibility funds.
- Social responsibility funds received from other sources can be accumulated.

Financial assistance for the activities of the scheme

- A student admitted under this scheme will pay a total of Rs.5,000/- (literally Rs.three thousand only) for registration fee, effort and accommodation expenses for research paper presentation in seminars, group discussions etc. or participation in Sho workshops.
- Patent Registration Fees will remain payable.
- 50 per cent or maximum of Rs.5,000/- of the total aggregate expenditure incurred on registration fee, effort and training expenses of a student participating in National/Inter-National Sports, Cultural and Research Competitions (excluding competitions organized by All India University Association, Delhi (AJU)) - (Literal rupees five thousand only) amount whichever is less shall remain payable.
- Admission/examination fee and other assistance will remain payable.
- Security to be deposited for obtaining library books required during the examination period. The amount will also remain payable on condition of refund to the students.
- Colleges may modify the sub-committee rules as per their level requirements.

Allocation of Funds:

- In exceptional circumstances, the Student Development Officer (SDO) will send the application received from the needy students for this purpose as per the recommendation of the Head of the Education Department keeping in mind the urgency of the application. The Principal will issue the Accounts Check after obtaining the approval of the Hon.
- After allocating the amount of the total fund accumulated under the said scheme, the fund can be appropriated by taking a decision from time to time regarding the balance amount at the end of the year, rights and privileges

The authority to grant financial assistance to the activities being started for the students of the college under the "College Student Responsibility Fund Scheme" (CSR) and to approve or disapprove the student financial assistance in accordance with the funds received under this scheme. Chairman of the Committee/Hon. Principal will remain.

For this scheme, the department heads of the college, teachers and non-teaching staff of the college are implementing the scheme through donations received from various sections of the society. Therefore, the college is determined to accept the responsibility of the needy and prospective students according to the available funds. If a student does not receive financial assistance from the available funds, his entitlement will not be binding on the college. Distribution of scholarships:


Scholarships will be distributed to selected scholarship awardees by honouring them in the Annual meet of the Alumni association. This gives a lot of encouragement to these students.

Introduction: - Dr. Panjabrao Apakhya Bhausaheb Deshmukh Shri Shivaji Education Society Amaravati in 1932 to facilitate the education of the children of rural farmers, agricultural labourers, labourers, economically and educationally backward families. Lakhs of boys and girls have completed their education from the schools and colleges set up by this organization and today they are leading a dignified life in the society. Even though the number of schools and colleges have increased, the facilities have increased, the facilities for grinding mills have been made available, even today these facilities have not reached enough to some sections of the society. Financial difficulties have not abated. As a result, some children struggle to stay in mainstream education. Children in rural areas must struggle to stay in the mainstream of education. Considering this problem of boys and girls in rural areas, Sri Shivaji Secondary and Higher Secondary Employees Welfare Society donated Rs.27,00,0,00 (Rupees Twenty-Seven Lakhs). The organization deposited this amount in the bank as a permanent deposit. A proposal was made to the institution to provide scholarships to needy, promising and intelligent students from the interest of this amount. The executive council of Shri Shivaji Education Society approved it as per the reference resolution and “Dr. Punjabrao Alias Bhausaheb Deshmukh Scholarship Scheme” was launched. The implementation of this scheme was to be done from the year 2020-2021, but due to the Corona outbreak, the proceedings had to be postponed in the academic year 2020-2021 and 2021-2022. Scholarships will be distributed as per this scheme from the year 2022-2023.

Nature of the scheme and outline of the proceedings

1. Compulsory School Scholarship –

A) One student and one female student studying in secondary schools in all rural areas under Shri Shivaji Education Society and securing the highest marks in the secondary school certificate examination will receive a cash scholarship of Rs.5000/- each (Rs. five thousand

B) A cash scholarship of Rupees 5000/- (Rupees Five Thousand) will be given to one student and one female student studying in secondary schools in urban Prag under Shri Shivaji Education Society and securing the highest marks in the secondary school certificate examination.

2. Higher Secondary Level Scholarship –

A) Cash Scholarship of Rupees 10,000/- (Rupees Ten Thousand) each to one student with the highest marks in JEE examination and one student with the highest marks in NEET studying in a Higher Secondary School or Junior College under Shri Shivaji Education Society will be given.

3. College Level Scholarship –

A) A cash scholarship of Rs.10,000/- (Rupees Ten Thousand) each will be given to a maximum of ten needy, studious and meritorious students studying degree courses (except for professional courses) in colleges under Shri Shivaji Education Society Amaravati.

B) A cash scholarship of Rs.10,000/- (Rupees Ten Thousand) will be given to maximum four needy, studious and meritorious students pursuing postgraduate degree courses (excluding professional courses) in colleges under Shri Shivaji Education Society Amaravati.

Terms Conditions and Rules

- Dr. Only students studying in secondary schools, higher secondary schools and colleges run by Shri Shivaji Education Society Amaravati will be eligible for the Punjabrao Deshmukh Scholarship.
- Marks obtained in the first attempt in the respective examination will be considered for Middle School Level Scholarship and High School Level Scholarship. Students appearing for re-examination will not be eligible,
- Students admitted to the first year of undergraduate and postgraduate courses can apply for the scholarship,
- College to select the needy, promising and studious students in the college

- A three-member committee should be constituted at the level.
- Very needy, ambitious and studious by screening the application received at the college level.

Students should be selected, and priorities should be decided, and the first three applications should be submitted to the institution with the signature of the principal along with the clear recommendation of the selection committee.
